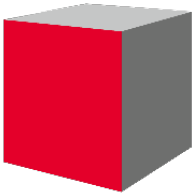

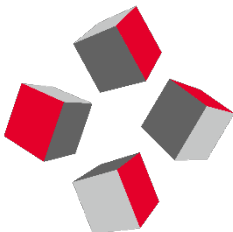
Creative presentation at the POS
